- It is equipped with a bag-stretcher fixed to the cover, two plastic hooks to fix the bag and one cage for deodorant or disinfectant pills
- It is equipped with an ergonomic handle and 125 mm plastic wheels to handle it better and easier
- The front door allows the emptying of the rubbish in a very simple way and without the minimum effort for the operator, 250° opening of the door studied to reduce the overall dimensions
- The pedal is internal the container structure so to reduce the overall dimensions and the rod to lift the cover is completely made of plastic
- It can be equipped with several accessories, such as a multipurpose plastic basket , a paper-roll holder with cover and hooks to carry small cleaning tools (dustpans, scrapers, etc.)
